Members of the public may sign up to ride *Brava!*, the roller coaster in *EJ Hill: Brake Run Helix*. MASS MoCA Members can sign up for a reservation beginning October 31, with reservations opening to the general public on November 2.

The ride departs from the second floor of the exhibition, beginning with a 12-foot drop. It lasts approximately 27 seconds, reaching speeds of approximately 30mph before coming to rest on the wooden stage on the floor of the gallery.

Before riding the roller coaster, participants are asked to sign a release and waiver and assert in writing that they are 18 years of age or older, are in good health, and understand the risks inherent to riding the roller coaster. (Guests 15-17 are permitted to ride if their legal guardian signs the waiver on their behalf.) Riders must be capable of entering and exiting the cart under their own power and must be at least 40" tall, weighing no more than 300lbs.

Limitations on riders

- The Roller Coaster riders must be at least 40" [101.6cm] tall. There is no maximum height; however, all riders must be able to fit properly in the seats, with the seatbelt fastened across their lap.
- Only one (1) rider is permitted per seat location, and all riders must enter/exit without endangering themselves or others. All Roller Coaster riders must exhibit independent seated postural control under the dynamics of the ride and have sufficient control of their upper torso, including the head and neck.
- Riders must also be able to sit in the seat as it was intended, and the seatbelt must be
 able to close and lock properly. Given that a rider can sit in an open seat and securely
 fasten the seatbelt across their lap, there are no limitations on passenger placement or
 recommended balance of passenger loading or unloading for the Roller Coaster.
- The Roller Coaster has a passenger capacity by weight of 300 lb/person (136.1 kg/person). However, note that the size and shape of the ride vehicle will likely prevent passengers of this size from riding.
- Riders must have a minimum of one (1) full functioning leg and one (1) full functioning arm.
- Guests should not ride the Roller Coaster if they have any heart condition, neck/back issues, blood pressure condition, recent surgery/illness, or are under the influence of drugs/alcohol. Pregnant guests should not ride. Full-arm and full-leg casts are not permitted.
- All riders must display appropriate mental and physical capacity to assist in their own evacuation.
- Loose articles are not permitted, including unsecured assistance devices or unsecured prosthetic devices. Food and drinks are not permitted.

Rider responsibilities

There are inherent risks in the participation in or on any amusement device. Riders accept the risks inherent in such participation of which the ordinary prudent person is or should be aware.

- Riders shall exercise good judgment and act in a responsible manner while using any amusement device. Riders shall obey all oral warnings by the ride operator, certified maintenance mechanic, or any inspector.
- Riders shall obey all instructional and warning signs clearly posted on the amusement device.
- Riders shall not place themselves on any amusement device when under the influence of drugs or alcohol.
- Riders shall use all amusement ride safety devices provided on a ride to ensure their safety. No person shall bypass, remove or make any safety device inoperable.
- Riders have a responsibility to notify the ride operator of any pre-existing health conditions that may negatively affect the health and safety of the rider if he or she were to ride the amusement device.
